I. CLIMATE AND ENERGY PROGRAM - Great Rivers works to address climate change  
by decreasing carbon emissions and encouraging cleaner energy. Missouri's  
electricity is among the most coal-intensive in the country, at 80%. Almost  
no coal is mined (or oil or gas drilled) in Missouri, and we have good wind  
and solar potential. Our utilities' coal-burning power plants are old and  
lack up-to-date pollution controls which keeps them relatively cheap at the  
expense of the public's health and a stable climate. Great Rivers appears  
regularly before the Missouri Public Service Commission, the state's utility  
regulator. Where environmental voices were never heard before, we represent  
traditional environmental advocates like Sierra Club and Natural Resources
